



## RE-CERTIFICATION FAQ'S

- HAVE YOU TAKEN A BOATING COURSE BUT HAVE MISPLACED YOUR CARD?
- HAVE YOU FORGOTTEN WHAT ORGANIZATION GAVE THE COURSE?
- ARE YOU UNDER THE AGE OF 26?
- ARE YOU OPERATING A BOAT WITHOUT THE PROPER BOATER ID ON BOARD?

IF YOU ANSWERED "YES" TO ANY OF THESE QUESTIONS, WE MAY BE ABLE TO HELP.

THE LAKE NORMAN SAIL & POWER SQUADRON (LNPS) IS OFFERING TO TEST ANYONE 18 TO 25 YEARS OF AGE WHO HAS PREVIOUSLY TAKEN A NASBLA APPROVED BOATER SAFETY COURSE AND HAS LOST THEIR ID CARD.

TO QUALIFY, APPLICANTS WILL NEED TO \* CERTIFY THAT THEY HAVE COMPLETED A NASBLA APPROVED BOATER SAFETY COURSE SUCH AS THOSE PROVIDED BY THE USPS, USCGA, NC WILDLIFE COMMISSION, ETC. YOU WOULD THEN BE ELIGIBLE TO TAKE A RE-CERTIFICATION EXAM. UPON PASSING THE EXAM, YOU WILL BE ISSUED A BOATER SAFETY PHOTO ID CARD AND A CERTIFICATE BY THE UNITED STATES POWER SQUADRON.

APPLICANTS WHO DO NOT PASS THE TEST CAN CHOOSE TO RE-TEST AT A FUTURE DATE OR BE ELIGIBLE TO TAKE A BOATER SAFETY CLASS AT A REDUCED FEE.

(IF YOU HAVE BEEN CERTIFIED RECENTLY BY PASSING THE LNPS BOATING SAFETY COURSE AND IF WE HAVE YOUR INFORMATION IN OUR RECORDS, WE MAY BE ABLE TO REISSUE A CERTIFICATE FOR A SMALL FEE WITHOUT EXAMINATION.)
