Proposed District 1 Bylaw Modifications

In the 2020 Audit, the Audit Committee recommended that the approval of the annual budget be moved from the Fall Conference to the Spring Conference. The purpose of this was so that the District Treasurer could more accurately estimate the majority of the next fiscal year's costs.

This proposal was made to the Spring Conference and was approved. Following that vote, the Rules Committee Chair, Betsy Tyrrell, contacted the National Rules Committee to get their approval. They did approve it but also suggested a few modifications to bring our Bylaws up-to-date with the National 'model' bylaws. These changes were approved at the 2021 June Council Meeting and will be presented and brought for a final vote at the Fall Conference. Following approval, they will be submitted to National and made permanent.

We are sorry to report that Les Williams passed away on 18 October leaving his wife P/D/C Elaine L. Williams, AP, 4 Children, 6 grandchildren and 6 great grandchildren.

Les entered the State police in 1962, retiring in 1989 with the rank of Captain. He then was Director of the Law Enforcement Council of southeastern CT, a consortium of 23 police departments. For 41 years He was an adjunct faculty lecturer at Three Rivers Community college in Norwich in the Criminal Justice program.

Les served his Saybrook Squadron and our District for over 43 years and earned 29 merit marks. He became a 'Life' member in 2017. Les was Education Officer of the Saybrook Squadron and was our District Education officer from 2005 to 2008. Many of us remember his animated ABC Instructor recertification classes. Following that, Les served on the District Planning Committee from 2008 to 2015. Les also served our National Organization as a Staff Commander on its Instructor Development (ID) Committee from 2005 to 2012.

Fall Conference Program

Do you use DB 2000 to get your Squadron/District job done? If so, you will want to come to the Fall Conference to hear about its replacement, 'The Information Center' or 'IC'. Yes, DB 2000 is going away; sometime after January 1, 2022!

P/D/Lt/C Cliff McKibbin will introduce the new system, its advantages, and the practical aspects of updating a member's email, pulling off an email or mailing list, updating your OD-2, getting a list of all of your 'P' members so you can promo the 'AP' course to them, finding a phone number for a member, etc.

The IC has several advantages over DB 2000. Among them are: ability to work on any computer without downloading the software (including Apple computers); directly work with your Squadron's roster without downloading it every time; ability of Squadron officers to use it without a password; your updates are immediate—no need to 'upload' them.

If you are a Squadron Officer that relies on DB 2000 to get Rosters, Email Lists, Labels, or handle the updating of the National records, you will need to start working with the IC. Don't miss this presentation.
