### **District 1 Fall Conference**

The District Fall Conference was held on 20 November, 2021 at the Pattaconk YC. This was our first 'return' to Pattaconk since its devastating fire in 2014.

P/D/Lt/C Clifford McKibbin, SN gave a power point presentation on the new National Information Center (IC). He noted that DB2000 will be going away as early as Jan 1, 2022. The new system does not require you to download any software and does not require the "import' of the National database as did DB2000. When you update member information it does not require an 'upload'. Updates of member information are actually easier using the IC. He stressed the need for everyone who uses DB2000 to get into the IC as soon as possible and become familiar with it so you can set up your email extracts, rosters, and mailing lists. Your OD1 and OD2 for this spring has to be done using the IC. All of Cliff's slides can be viewed on the District website in a PDF by going to the fall 2021 issue of Sounds of 1. There are two videos on Information Center on the National 'Information Center' main menu.

## Chief Commander's Representative: P/R/C Michael Friedman, N

Stf/C Michael Friedman, N, Vice Chair of the National Committee on Nominations together with his wife of almost 48 years, Ruth Witztum, JN (Stf/C of LawCom) joined the New York Sail and Power Squadron in late 2001, the year he and his wife purchased their first sail boat, a well-used 1980 Beneteau First 30, and joined Miramar Yacht Club in Sheepshead Bay Brooklyn, NY. Mike and his wife were avid scuba divers which led inevitably to boating. First, they were 1/10 owners of a 30ft life boat converted to use as a scuba club dive boat in Taiwan in 1976 and then after returning to NY acquired a pair of ocean kayaks outfitted for diving and touring. They now own a Sabre 362 which they sail in New York waters and cruise to Long Island Sound, Block Island and Buzzard's Bay.



Mike has served as SEO and Commander of the NY Squadron / America's Boating Club of New York as well as Commodore of Miramar Yacht Club. He has assisted teaching squadron ABC-3, Piloting and Navigation courses. Mike has also served and is continuing to serve as the District 4 Law Officer and remains active in the NY Squadron.

Mike's first introduction to our National organization was being "Shanghaied" to join the Law Committee in 2006, and he was elected National Law Officer in 2017. There will be no Mates Program or Ship Store at the D1 Spring Conference.


