On another item, you may notice that NOAA has cleaned up the "Small craft reports previously submitted" page by removing most reports more than two years old. This does not mean they are removed from the charts. You can still report them as "Updates". By the way - Chart 13229 has been updated as of Sept. 2010. I have not yet seen a new edition (# 31).





Vessel Safety Check – P/D/C W. Lee Blackburn, SN, District Chairman

The District 14 Vessel Safety Check Program had a very active year in 2010. There were 42 Vessel Examiners who checked a total of 569 boats of which 513 passed and were awarded a 2010 VSC decal. That is good news and we all should be proud of the efforts put forth by our D14 Vessel Examiners. Unfortunately the Narragansett Bay Squadron did not participate.

Fourteen of these Vessel Examiners will receive a Certificate of Appreciation, at the Spring Conference, for matching or exceeding the national average for the number of VSCs done by a Vessel Examiner. The national average was 15 VSCs. Five squadrons are represented by these fourteen VEs. Additionally there are awards for the top 3 individuals.

The Certificate of Appreciation represents an outstanding accomplishment by a third of our Vessel Examiners. As always, there are those who needed only a few more VSCs to get the certificate. I realize that not all members have the same amount of spare time to devote to these activities thus it is with heart felt appreciation that I thank all those VEs who were able to do any VSCs . . . every single one counts toward the goal of 1 more safe boater out there.

With the passing of Art Kimber we lost a good friend and a very active Vessel Examiner. He was, and still is the only VE in this district to do 100 VSCs in a single year. As a matter of fact, he did 21 VSCs this year. The First Place Award will continue to be awarded honoring Art Kimber.

The top individual Vessel Examiners are:

Once again the Greenwich Bay Squadron will receive the District Commanders Bowl, for having the highest percentage of certified Vessel Examiners to the total squadron membership. The national average is 5.7%. That is about 1 of every 18 members nationwide is a VE. We have 3 squadrons; Cape Cod, Newport and Taunton River who's VEs range from 5 to 6% of the membership. But, at 19.7% Greenwich Bay stands out as almost 1 of every 5 squadron members is a Vessel Examiner. Greenwich Bay's involvement in the VSC program is to be commended. As a matter of fact, they will again receive national recognition, by meeting the requirements of

having 10% or more of their members as qualified VEs and performing sufficient VSCs to equal or exceed their number of members.

As far as volume of VSCs is concerned, we have 3 squadrons who's VEs combined did over 100 VSCs; Greenwich Bay -217, Cape Cod -135 and Taunton River -113.

During the year we lost some VEs and gained others. By the end of the year we had 42 VEs, the same number as last year, however, we had 8 who <u>did not do</u> at least 5 VSCs, the minimum required to remain qualified unless this is their first year. Altogether we did 18 more VSCs than last year. That is truly an accomplishment for all involved in this program.

District 14 will host a Vessel Examiner's Class and Refresher on Saturday 30 April 2011 at the Rhode Island Yacht Club in Cranston, Rhode Island. Please watch the D14 website for further details. Each squadron is urged to send members who might like being a Vessel Examiner. Also, this is a good review and update for qualified Vessel Examiners. They will benefit by attending.
