### Description of Project (please limit to 300 words):

The National Membership Jamboree Committee is asking the Education Fund to provide a grant that will fund the Patch and printed materials only needed at the USPS booth during the 2010 BSA Jamboree.

With more than 43,000 Scouts and leaders expected to attend the 2010 Jamboree, USPS is constructing a booth to display the educational opportunities offered to BSA youth and leaders. This booth will be both an interactive and a static display of our educational materials. Youth will be asked to complete several activities designed to test their Boating Safety Knowledge. These activities are:

1. "It's in the Bag" – Blindfolded scouts must remove a PFD from a sealed package, don it correctly and adjust it within a 20 second frame.
2. "Match the PFD To Its Use" – The activity challenges the scouts to match a group of four PFDs to their typical use.
3. "Find Five Things Wrong With This Boat" - Will the scouts to find five things wrong with a 16' trailerable boat which will be located outside the exhibit tent adjacent to the USPS display booth. The trailerable boat has been specifically altered to place five problems on the boat.
4. "Boating Knowledge Quiz" - The activity challenges the scouts to answer a seven-question boating knowledge quiz.
5. Operation of the Volvo Penta IPS Simulator - The simulator allows the scout to actually operate a joy stick and experience the operation of a boat by steering the vessel, forward and reverse, navigating a course and docking a vessel. Each USPS exhibitor will teach a youth to operate the simulator and under his/her supervision the scout will perform each operation (forward, reverse, navigating a course and docking a vessel) successfully.

Award for successful completion - Each scout who successfully completes these five tasks will be awarded a commemorative USPS/BSA Jamboree 2010 patch. If we find that we don't have enough patches, a system of drawing for a patch using raffle tickets has been devised.

4. Any unused grant funds remaining at the completion or termination of the project will be treated as uncommitted funds of the USPS Educational Fund and used by the Trustees to underwrite other grants.
5. The USPS Educational Fund and the Trustees shall have no responsibility or liability with regard to the project for which the grant was made.
