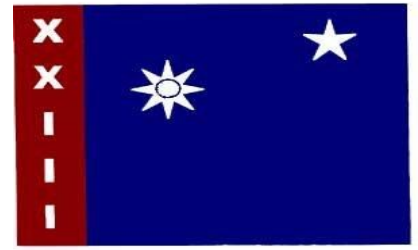

## EDUCATION UPDATE



Greetings from the D23 Education Department. I would like to start off with a thanks for allowing me to continue as your District Education Officer. It's an honor and a privilege to serve again this year.

The Education Department at the National Level is working diligently on updates and improvements. Our NEO Chuck Wells and his staff work countless hours on rewriting course materials to meet our changing needs. The Marine Navigation Course is now complete along with an updated Cruise Planning Course. Offshore Navigation and Cruising Under Power and Sail are in the Beta Trial. Close to completion is the stand-alone Celestial Navigation Course (the student will not need any prerequisites for this course).

As I reported at the Spring Conference ABC3 has undergone some changes. The new Powerpoint Presentation now includes the new PFD labeling, changes in the Fire Extinguisher and the Emergency Cut Off Switch (ECOS) information.

If you hear a rumor that Florida will be going to a 75-question test (60 from the book /15 from the state section). It's true BUT NOT at the PRESENT TIME! The new test is NOT ready at the present time so continue using the 60-question test. If you need to download the new PPP let me know and I will send you the information.

National is helping the Districts and Squadrons with information on any student the request the ABC3 Course online. They send the names and contact information by ZIP Code to the District Coordinator, Sandy Schoonmaker, SN. Sandy sends out a very nice email to the student offering assistance and also copying the squadron SEO or Contact person. This is a great opportunity to gain a new member. **Please let Sandy know that you have attempted to make contact with them.**

In 2023 we did not have a Chapman Award Winner, so there are some changes coming for 2024. I will be sending out more information in the coming weeks. Start Thinking about your Squadron Submission they will be due by 1October, 2024.

Squadrons are asked to bring a basket to raffle and bring your life jacket for our group photo.

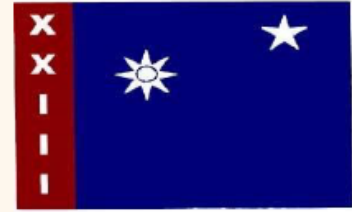

## INTERESTING FACTS AROUND OUR DISTRICT

### The Banana River Circle



Florida's newest antique discovery, the Circle in Banana River, has piqued the curiosity of historians and locals alike. This peculiar artifact, protruding from the water, presents yet another intriguing chapter in the history of the Sunshine State. Despite its initial resemblance to the famed Stonehenge, it turns out to be something quite different. Strangely enough, this circle is

not a relic from an ancient civilization but rather a remnant from the World War II era. It was found near SR 528 in the river, rusted and covered in barnacles, adding a touch of mystery to the already unique part of the Space Coast. According to an article by [Malcolm Denmark](#) in Florida Today, the circle is a remnant from World War II. This revelation counters initial theories that proposed the structure as a fish trap or even Florida's own "Stonehenge". Instead, it was identified as a target used for training pilots during the war, with several more similar structures located around the area.

## National and District Awards Continued

### Prince Henry the Navigator



In the early 1960s the government of Portugal, at the embassy in Washington D.C. discussed creating an award in honor of Prince Henry the Navigator who, in the early 15th century, started a school of navigation in Sagres, Portugal to advance the science of navigation. Ultimately the Portuguese government awarded an **alabaster replica of Prince Henry** to each of the Districts of USPS. The deed of gift gave each district the authority to establish its own criteria for earning the award.

In District 23 Prince Henry is awarded to the squadron having the greatest percentage of achievement in three grades, AP, JN and N. The squadron to receive the award is determined by applying a weighted average for the number of candidates advanced to those grades with 1 point for AP,

2 points for JN, and 3 points for N. This year the award was presented to **Daytona Beach**.

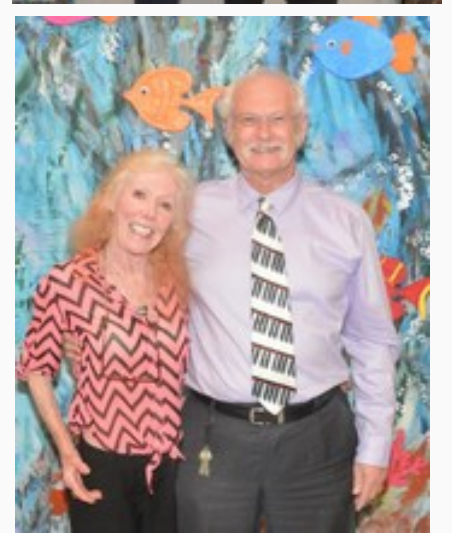

## America's Boating Channel™ Warns of Electric Shock Drowning

Electric Shock Drowning (ESD) is a little-known and often-unknown killer, severely injuring and killing people every year. It occurs when faulty wiring sends electric current into water, which passes through the body and

causes muscle paralysis that can result in drowning.

Faulty wiring or the use of damaged electrical cords and other devices on docks and boats can cause the surrounding water to become “energized,” with no visible warning. Avoid getting in the water within 150 feet of where AC power is in use and learn how to test if dangerous electrical currents are in the water around your boat.

To help boaters understand the danger of Electric Shock Drowning (ESD), Season Four of America’s Boating Channel offers the video “[Electric Shock Drowning \(ESD\)](#).” The video shows how ESD causes deaths and injuries at marinas nationwide, including many undetected incidents. Viewers also will learn about ESD prevention and how to install ground protection on docks and boats. Also featured are differences between ESD dangers in saltwater and freshwater.
