2023 Spring Conference (excerpts from the minutes of D/Lt/C Linda Lewis, AP)

The 2023 Spring Conference was held on 18 March at the East Glastonbury Fish and Game Assoc in Marlborough, CT.

Cdr Art Andrea, AP called the meeting to order. The presentation of colors was led by D/Lt Ken Bell, Sr. AP followed by the Pledge of Allegiance accompanied by bagpipe music by 1SG Mark Otterson, 2nd Co. Governors Foot Guard. The Invocation was given by District Chaplain D/Lt Paul Bialecki, P.

Chaplain Bialecki then led a memorial service for deceased members in the last year (see page 7). A candle was lit for each as the bell tolled. The bagpiper played Amazing Grace following the reading of the names.

D/Lt/C Pat Pabouet, P introduced our guest speaker, Richard Simon, owner of Shoreline Diving Services, LLC which does underwater inspections of dams, boats, salvaging, anything to do under water.

He talked about the U Boats of WWI and WWII and the hundreds of wrecks in Long Island Sound that are deteriorating due to storms, waves, and tides. He noted a Norwegian freighter, the Volund, which collided in the fog at the Race 100 years ago. He mentioned that there are sunken subs that were used for target practice.

He talked about the importance of knowing what you have for insurance on your vessel, the coverage and the dates of said coverage. You don’t necessarily have coverage when you venture out of your immediate area. Always check!

The members broke into three groups for ‘Breakout Sessions’ with the Commander, the Education Officer, and the Secretary.

Following an excellent lunch, the meeting resumed with the reports of the officers, followed by the vote to approve the Auditor’s Report presented by P/D/C George M. Gilbert, JN and the vote to approve the 2023-24 Budget presented by District Treasurer Lt/C Peter Jenkin, SN. V/C Charles Wells, SN, our National Education Officer, zoomed in for our election and installation of officers.

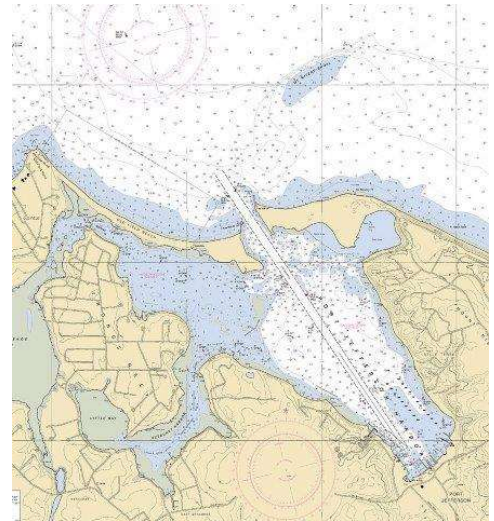
Currents: Flood starts 7/7, 9:42 AM Friday for an early start

Get your Squadron more involved with Civic Activity.

Two Power Squadron activities that do a lot of good for the boating community are:

Vessel Safety Checks. You can become a Vessel Safety Examiner and be your Marina's 'go-to' person for inspections. Your fellow boaters will appreciate having the USCG sticker attesting to the fact that they have been inspected and met the basic requirements for boating safety. It may even save them a USCG inspection.

You will take a short course, pass a test, and do 5 checks a year to maintain your qualifications. Contact D/Lt/C Pat Pabouet, District VSC Chair, at argus06108@aol.com to find out more.

CoOp Charting. Again, you can help the boating community as well as the USCG to make sure Nautical Aids to Navigation (ATONs) are properly located. We also report problems such as missing numbers, poor paint job, obscured by foliage, etc.

Going on a CoOp outing is a fun group event with a few hours checking ATONs and perhaps a lunch at a landing. Reports of problems are then made to the USCG and all inspections are reported to the USPS CoOp Committee for credit. All the reporting is on-line and fairly straight-forward.

Our District was 8th in the country due to Hartford's efforts. If a few more Squadrons got involved, we could do even better.

- Hartford has 'adopted' the CT River but that doesn't stop other Squadrons from checking it as well.
- No Squadron has adopted other major waterways in CT. There are a lot of them. These include: New Haven/Branford area, the Milford area, the Housatonic River, Niantic Bay, the Thames River, Mystic/Stonington/Watch Hill/Fisher's Island.

America's Boating Channel Urges Use of Engine Cut-Off Devices

Are you aware of the legal requirement for using engine cut-off devices? This is a requirement that could save your life.



The requirement to use an engine cut-off switch (ECOS) took effect on April 1, 2021, and applies to all U.S. waterways, with fines of \$100, \$250, and \$500 for the first, second, and third offenses, respectively. State and local authorities may choose to enforce the law differently, but using an engine cut-off switch is now the law for qualified vessels everywhere in the United States.

The law applies to all personal watercraft and recreational boats under 26 feet with motors capable of 115 pounds of static thrust (a little under 3 horsepower). Boats not currently equipped with an engine cut-off switch are exempt, but that grandfather clause is closing fast. Another recent federal law required manufacturers to install engine cut-off switches on all new boats starting in January 2020.

It covers differences between boating knowledge and boating skills and why it matters. Viewers learn approaches to take to improve their boating abilities.

CT-DEEP Sets New Minimum and Maximum for Striped Bass

The Atlantic States Marine Fisheries Commission (ASMFC) took emergency action earlier this month to implement a 31-inch maximum size limit on recreational striped bass fisheries along the Atlantic coast.

To come into compliance with the ASMFC emergency action, CT DEEP has implemented a new 28-31" harvest slot limit for striped bass effective May 26, 2023. The new 28-31" harvest slot limit means that any striped bass that is less than 28 inches or greater than or equal to 31 inches must be released without avoidable injury. This regulation will apply to all waters of the state (marine and inland district).

2021 U.S. Coast Guard Boating Statistics

- The fatality rate was 5.5 deaths per 100,000 registered recreational vessels based on 4,439 accidents involving 658 deaths and 2,641 injuries. This rate represents a 15.4% decrease from the 2020 fatality rate.
- Property damage totaled more than \$67.5 million.
- Alcohol use is the leading known contributing factor in fatal boating accidents; where the primary cause was known, it was listed as the leading factor in 16% of deaths.
- Where cause of death was known, 81% of fatal boating accident victims drowned. Of those drowning victims with reported life jacket usage, 83% were not wearing a life jacket.
- Where length was known, three out of every four boaters who drowned were using vessels less than 21 feet in length.
- Where instruction was known, 75% of deaths occurred on boats where the operator did not receive boating safety instruction.
- There were 188 accidents in which at least one person was struck by a propeller. Collectively, these accidents resulted in 24 deaths and 191 injuries.
- Operator inattention, operator inexperience, improper lookout, , machinery failure, and excessive speed rank as the top five primary contributing factors in accidents.
- The most common vessel types involved in reported accidents were open motorboats (47%), personal watercraft (19%), and cabin motorboats (13%). Where data was known, the vessel types with the highest percentage of deaths were open motorboats (44%), kayaks (15%), and pontoons (10%).
