# My View From the Boat Ramp

The boat ramp is the beginning and the end of an adventure whether it be fishing, wakeboarding, tubing, or just a pleasant cruise. Most times it is a pleasant adventure, sometimes not. To me it is more than this. It is a source of amusement.

Too hot to be out on the boat ramp but I did pick up some other interesting observations.

Summer is here and the drownings are happening. A man fell off the tube he was riding and drowned. Of course, he wasn't wearing a life jacket! It was probably still in the boat in the plastic shipping wrapper so it wouldn't get dirty. Another drowned while swimming in a swimming area that didn't have a lifeguard.

I saw a person on TV news program that said most boating accidents involve alcohol. Interesting that someone would notice.

I witnessed an interesting feat at a party the other day. Champagne was to be served. The server produced a bottle of champagne that had been placed inverted in an Ice bucket. (How crude. A campaign bottle should never be inverted before serving.) He then obtained a large swashbuckler type sword from an assistant. HE then took the sword and broke the neck of the bottle off sending the broken glass neck into the midst of the guest and spewing campaign onto the floor. Everyone cheered.

This was interesting but I serve champagne a little differently. I would first place it into a bucket vertically and fill the bucket with ice. Then I would place a towel over it and let it rest a few hours. (You may have noticed that the bottle used for sparkling wine has a different bottom. Sparkling wines continue to ferment in the bottle. This bottom is designed to hold any sediment present; thus, I would never invert or disturb the wine in any way.)

At the time for serving, I would gently remove the bottle from the ice using the towel and wrap the bottle in the towel much like you would a newborn baby. (I would never touch the bottle with my warm hands.) At this time I would ask a blessing on the wine, the laborers who picked the grapes and the hands that made it into wine. The cork is removed in the conventional manner, not spilling a drop of the precious nectar. The cork would then be placed into my left pocket to be used as a float when I go fishing. A small portion of wine would be poured int a glass to be tasted lest it has been turning into vinegar due to improper handling. The wine is now poured into glasses for the guests being careful not to bruise it. The last bit of wine would not be served as it may contained some sediment. It would be poured into the dog's water bowl so as not to be **wasted**.

The bottle could be used in many ways. You could make a candle holder, a lamp, or even build a ship inside.

## Some Comment's About Life Jackets

Wisconsin's Fox River has been home to native peoples, the main thoroughfare for transporting goods, a source of hydroelectric power, ground zero for the state's paper industry and is now having a renaissance of recreation and environmental awareness. Today, the 39-mile stretch of the Fox River is home to paddlers, boaters and pedestrians who can watch an engineering marvel in operation. The river features a system of 17 locks and dams. What makes the system unique is that the locks are fully hand operated and historically restored to their original state when they were built from the 1840s to



the early 1900s. All locks are on the National Register of Historic Places.

As we can see, all the boaters have a life jacket on. Having spent a lot of time in the locks on the Illinois and Mississippi rivers, I would not recommend a Kayak in those locks with all the turbulence A Life Jacket is one of the least expensive boating safety items that can save your life. Size and Fit are important. Check the label for user weight and chest size. Different body types float differently. Try your lifejacket on in the water to ensure your airway is clear. A good fit is secure, comfortable, and adjustable. Though not always required by law, a lifejacket should be worn at all times when the vessel is underway. A wearable lifejacket can save your life, but only when you wear it. Wearable lifejackets must be readily accessible. You must be able to put your lifejacket on in a reasonable amount of time in an emergency. Lifejackets should not be stowed in plastic bags, in locked or closed compartments or have other gear stowed on top of them. A throwable device should also be immediately available for use. Many boaters have added Inflatable Lifejackets which may be easier and more comfortable to wear. Inflatable lifejackets require the user to pay careful attention to the condition of the device. Inflatable lifejackets must have a full cylinder and all status indicators on the inflator must be green, or the device is NOT serviceable, and does NOT satisfy the requirement to carry lifejackets. Inflatable lifejackets are not appropriate for weak or non-swimmers. Most important are the Child Lifejacket Requirements: Federal Law requires that when a vessel is underway, children under 13 years of age must wear their lifejacket, exceptions for when below deck or within an enclosed cabin. State laws may vary. Check with your state boating safety officials.



The Coast Guard recommends and many states require wearing lifejackets for water skiing and other towed activities. While operating personal watercraft (PWC) or sailboarding, use a lifejacket marked for water skiing or PWC use. If you are boating in an area under the jurisdiction of the Army Corps of Engineers, or a federal, state, or local park authority, other rules may apply.
