## IMPORTANT LETTER TO THE MEMBERSHIP:

Dear Fellow Members of the Winooski Valley Sail and Power Squadron,

Your squadron has come to a critical point in a history that spans nearly 50 years. We must decide whether or not we can commit to revitalizing the squadron. The alternative is to surrender our charter and disband the squadron or merge it with another squadron in the region.

The core of the problem is simple: lack of participation and commitment by members of the Squadron in the social events and our volunteer efforts, particularly in leadership activities.

Quite frankly, we need new blood. The same core of people has served as officers for several years and, through attrition and term limits, this is not sustainable. We face a leadership crisis right now. The future of the squadron is at stake.

This is especially troubling at this time when our current Basic Boating Course enrollment is at capacity and we have initiated several successful new two-hour seminars being held at West Marine. Our Vessel Safety Check program is active during the spring and summer, and our participation in last month's boat show drew several prospective new members. Our mission of boating safety and education is being fulfilled now, but it is in jeopardy.

Soon you will receive a call from one of the Executive Committee members listed below to determine how you feel about the future of the squadron and your own role as a member. Perhaps we have been remiss in not contacting you personally on an individual basis to encourage your participation, so this is a step in that direction.

The next step will be a Change of Watch meeting to install new officers and review the findings of our membership phone survey. It will be held at 6 p.m. Saturday, May 10 at the Holiday Inn in South Burlington. We urge you to attend this important meeting. We have specific needs for chairpersons of the Safety and Membership Committees, a Squadron Education Officer and assistant, as well as course instructors and Vessel Safety Check inspectors. Training is available. We hope you will consider what the squadron has done for you, and what you might now do to sustain it for future generations.
