# Painter Hitch. (no, not that kind of paint)

A long time ago I learned this knot to successfully tie up my dinghy to pilings and other vertical or horizontal objects that were hard to reach around or over from a dinghy. It is increditably useful as it slips away without needing to pull the working end around the object when freeing it. It lets you keep one hand for the boat and one for the painter as it avoids entanglement. Practise this one at home! Amaze your friends at the dinghy dock with your nautical skills as you pull up.

Let me know by email to jdob3542@aol.com with your ideas.	<ul> <li>Boating Tip of the Month:</li> <li>OKHere is something you should be aware of this Spring!</li> <li>Check your fire extinguisher for age!</li> <li>Like all things old, they tend to malfunction, (do not ask how I know). The Coast Guard, in its infinite wisdom, has concluded that if your on-board handheld fire extinguisher is more than 12 years old it is no longer considered serviceable.</li> <li>Each unit will have a two- digit manufacturing date stamp and must also state "Marine Type USCG" AND be appropriate for your vessel type and length.</li> <li>Check for the correct type and number of extinguishers required on the U.S. Power Squadrons or Coast Guard web sites.</li> <li>Any Vessel Safety Check (VSC) will call out this requirement whether done by marine police or Coast Guard\$applies if failed. Get a VSC with us no\$ applies.</li> </ul>
